

COMPETITION RULES

CaraMaps Summer Challenges

Article 1 – Organizer

CaraMaps SAS, with share capital of €350,000, hereinafter referred to as “the Organizer”, whose registered office is located at 19 rue Jules Noriac, 87000 Limoges, France, registered with the Limoges Trade and Companies Register under number 813 901 592, is organizing a competition entitled:

“CaraMaps Summer Challenges: Try to Win Gifts!”

The competition runs from June 15, 2026 at 10:00 a.m. to September 15, 2026 at 11:59 p.m. and is divided into six participation periods. A separate prize draw will be held for each period.

Article 2 – Participants

The competition is open exclusively to persons aged 18 or over residing in mainland France (including Corsica), Spain, Italy, Germany, Portugal, the United Kingdom, Belgium, the Netherlands, Switzerland, and Ireland.

Employees of the Organizer, persons involved in the design, implementation or management of the competition, and members of their households are not eligible.

Participation implies full acceptance of these rules.

Article 3 – Participation Terms

Participants must use the CaraMaps website or mobile application.

Each contribution validated by the CaraMaps team automatically grants one entry into the relevant prize draw. The more valid contributions submitted, the greater the chances of winning.

Eligible contributions:

- June 15–30, 2026: 🌅 Publish a sunset photo on a CaraMaps location page.
- July 1–15, 2026: 💬 Share your best experience on a location with a rating of 4 stars or more and a comment.
- July 16–31, 2026: 📍 Add a new location not yet listed on CaraMaps.

- August 1–15, 2026: 📸 Publish a photo of a location with a sea view.
- August 16–31, 2026: 📍 Add a tourist activity not yet listed on CaraMaps.
- September 1–15, 2026: 🚐 Publish a photo of your leisure vehicle in front of a service point or electrical hookup.

Only compliant, relevant and non-fraudulent contributions will be accepted.

Article 4 – Prizes

Prize 1: June 15–30, 2026 - a €100 gift voucher, redeemable at any Sunêlia campsite during the 2026 season.

The voucher has no minimum stay requirement, is non-transferable, cannot be split into multiple uses, and is non-refundable.

Any expenses incurred after the game, including but not limited to the maintenance and use of the prizes, shall be borne entirely by the winner.

Article 5 – Selection of Winners

This free prize draw, with no purchase necessary, is open exclusively to adults (18 years or older) who hold an active user account on the CARAMAPS application.

The following persons are not eligible to participate:

- * Employees of the organizing company;
- * Any person who has participated, directly or indirectly, in the design, organization, or management of the prize draw;
- * Members of the households of the persons mentioned above.

Participation in the prize draw constitutes full and unconditional acceptance of these official rules and regulations.

Article 6 – Winner Notification

Winners will be contacted by email within 7 days following the relevant draw. If no response is received within 15 days, the Organizer may conduct a new draw.

Article 7 – Prize Delivery

The arrangements for prize delivery will be communicated directly to the winner. Depending on the nature of the prize, some items may be shipped to the address provided by the winner, while others may be delivered directly by email.

Any costs associated with the use of the prizes that are not expressly mentioned in these rules shall remain the sole responsibility of the winner.

Each winner must confirm receipt of their prize within 15 days of dispatch. After this period, if no response is received or if the prize is refused, it will be deemed forfeited and no claim may be made in respect of it.

If a prize is returned as undeliverable, it will remain available to the participant for 15 days. After that period, the participant will no longer be entitled to claim it.

Winners agree to accept the prizes as offered, with no possibility of exchange, in particular for cash, other goods or services of any kind, or transfer of the benefit to a third party. Likewise, no compensation may be requested in relation to the prizes.

The Organizer reserves the right, in the event of circumstances beyond its control, including issues related to suppliers or other unforeseen circumstances, to substitute the advertised prizes with prizes of equivalent value. Winners will be informed of any such changes.

Article 8 – Use of Participants’ Personal Data

Participants’ information is recorded and used by the Organizer to register their participation in the prize draw and to enable the allocation of prizes.

For legitimate reasons, participants may object to the processing of their personal data provided in connection with this prize draw. They also have the right to object to the use of their data for commercial prospecting purposes unrelated to the prize draw. This right may be exercised at the time of registration by contacting the Organizer by post at the address specified in Article 1.

The winner(s) authorize the Organizer to use their personal details (first name and surname) for advertising or public relations purposes, in any medium, without entitling them to any remuneration, right, or benefit other than the award of their prize.

In accordance with applicable data protection legislation, including the French Data Protection Act (as amended) and Regulation (EU) 2016/679 of 27 April 2016 (GDPR), participants may exercise their rights of access, rectification, erasure, restriction of processing, data portability, objection, and withdrawal of consent by contacting the Organizer by post at the address specified in Article 1.

Article 9: Official Rules of the Prize Draw

A copy of the rules may be sent free of charge to any person who requests it from the Organizer.

The Organizer reserves the right to extend, shorten, modify, or cancel the prize draw at any time, particularly in cases of force majeure, without any compensation being payable to participants. Any amended version of the rules will, where applicable, be deposited with SELAS ACTA at the above-mentioned address.

Article 10: Intellectual Property Rights

The reproduction, representation, or exploitation of all or part of the elements comprising the prize draw, including these official rules, is strictly prohibited.

All trademarks, logos, texts, images, videos, and other distinctive signs reproduced on the website, as well as on websites accessible via hyperlinks, remain the exclusive property of their respective owners and are protected worldwide by intellectual property laws. Any unauthorized reproduction constitutes infringement and may result in criminal penalties.

Participation in this prize draw implies full and unconditional acceptance of these rules.

Article 11: Liability

The Organizer shall not be held liable in the event of force majeure or circumstances beyond its reasonable control.

The Organizer shall not be responsible for delays, losses, theft, damage to mail, or illegible postmarks caused by postal services. Likewise, no claim may be brought against the Organizer in the event of circumstances constituting force majeure (such as strikes, severe weather, etc.) that partially or totally prevent participants from taking part in the prize draw or winners from receiving their prizes.

Neither the Organizer nor its service providers or partners may be held liable for any incidents arising from the use of the prizes by winners or their guests once the prizes have been delivered.

Similarly, the Organizer, its service providers, and partners shall not be liable for the loss or theft of prizes after they have been received by the winners. Any additional costs associated with taking possession of the prizes shall be borne entirely by the winners, who may not seek compensation from the Organizer or its partners.

Article 12: Disputes and Claims

These rules are governed by French law.

The Organizer reserves the right to make final decisions regarding any difficulties arising from the interpretation or application of these rules. No dispute concerning the mechanics of the prize draw, the results, the prizes, or their delivery will be accepted more than one month after the end of the prize draw.

Except in cases of manifest error, information generated by the Organizer's systems shall constitute valid evidence in any dispute relating to connection data and the computerized processing of information relating to the prize draw.

Any claim must be submitted to the Organizer within one month of the end date of the prize draw. After this period, no claims will be accepted.

Participation in the prize draw constitutes full acceptance of these rules.

Article 13: Evidence Agreement

It is expressly agreed between the participant and the Organizer that the Organizer's computer systems and files shall constitute the sole authoritative evidence.

Computerized records stored in the Organizer's information systems under reasonable security and reliability conditions shall be considered proof of the communications and transactions between the Organizer and the participant.

Accordingly, except in cases of manifest error, the Organizer may rely, for evidentiary purposes, on any programs, data, files, records, operations, tracking reports, and other information stored, received, or maintained directly or indirectly in electronic or computer format within its systems.

Such records shall be admissible, valid, and enforceable as evidence in any legal or other proceeding to the same extent and under the same conditions as written documents.

Any operation carried out using the username and password assigned to a participant following registration shall be deemed, conclusively and without possibility of rebuttal, to have been carried out under that participant's responsibility.
